Covenants & Restrictions (C&R) Summary Common Violations & Enforcement



Parking

- Violation of Paragraph 11 Parking
- <u>Violation to park any vehicle overnight upon any public street in the association.</u> Any vehicle which is not parked in a garage, must be parked upon the driveway of the home. Parking in the yard is also a violation of the Restrictions. In addition it is a violation to store any recreational vehicle, boat, storage pod or camper in the driveway or upon any street in the association.
- C&R Notification Process per violation
 - 1st Courtesy letter provided to homeowner
 - Note: Letter shall only be provided to a Homeowner once in any twelve month period.
 - 2nd Any repeated violation within a twelve month period results in another written notification
 - 3rd In the event that both the first and second violation are for a repeated violation, the Homeowner will at that time be assessed a penalty of \$50.00 for the third and each subsequent offense

Flower Beds, Trees, Lawn Upkeep, & Basketball Goals

- Violation of Paragraph 10 Flower Beds, Lawn Upkeep, Disposal of Grass Clippings
- Violation of Paragraph 13 Basketball Goals
- C&R Notification Process per violation
 - 1st Courtesy letter provided to homeowner
 - Note: Letter shall only be provided to a Homeowner once in any twelve month period.
 - 2nd Written notification and the Homeowner will at that time be assessed a penalty of \$50.00 for the second and each subsequent offense

Covenants & Restrictions (C&R) Summary Common Violations & Enforcement



C&R Description	Violations
Front Yard Cleanliness (i.e. signs in front yard, flower bed weeds , front lawn, trees, etc.)	84 with 6 monthly fines
Cars Parked in street; Boats & RVs/Travel Trailers parked in street or driveways	46 with 8 monthly fines
Other (Dogs barking issues, Noise, Trash, Basketball Goals)	12

- Added a Compliance Officer to the board to assist with violation enforcement.
- Parking Compliance 98% Compliant
- Yard Compliance 96% Compliant
- HOA board continues to enforce C&Rs and follow the process with letters and fines.
- HOA board continues to implement improvements to the process. We will continue to confer with attorneys, OKC PD neighborhood compliance and other homeowners on suggestions so homeowners will comply with the C&Rs. Some homeowners will still choose not to comply.
 - Each letter written to a homeowner, the homeowner will also incur an administrative fee.
 - For repeat offenders, sending letters in addition to monthly fines.
 - Reviewing "cease and desist" actions with our lawyer to add to our procedures.

- Other Concerns
 - At the moment of violation or disturbance, file complaint with police at 297-1000
 - Police will not respond without a formal complaint by neighbor within area of violation/disturbance.
 - Barking Dogs File a complaint with the OKC Animal Shelter. Person filing complaint must be willing to testify in court that such dog is a nuisance.

Annual Report



Annual Report

- Budget for 2022 \$66,000
- Projected end of the year \$60,272
 - YTD \$51,008
 - Projected under budget (-\$5,362)
 - Includes an estimated \$10k for capital improvements to be used for fence and irrigation replacement
 - Capital Improvement contribution will be finalized at the end of each year based on final expenses and dues collections.
- Budget for 2024 \$66,000
 - Park contribution increasing by ~\$9k
 - Maintaining same budget by reducing other budget items
- Over 45% of the expenses are for the park and front entrance

2024 Invoices – Due by 1/31/24

- Dues are \$154.00 annual
- 2024 Invoices will be mailed and emailed
- Option to pay via check or electronic payment with QuickBooks
- Continue working with our lawyer to collect past dues.

□ Front Entrance Updates

- Adding additional professional services each year
 - Contracted a fertilization and weed control company
 - · Added professional landscaping for flowerbeds, mulch and tree trimming
 - Maintaining the same approach as the park for general landscaping and will continue to add more professional services.
- Only two (2) city streetlights allowed in area per OKC traffic manager
- Continue to review options to add more lighting
- Updated front entrance trees and shrubs, we will continue to replace trees and add colorful plants

Park Budget & Update



Park Committee

Members include: Both HOA Presidents and 3 members from each HOA

Park Operating fund is funded by both subdivisions; pro-rated based of number of homeowners

- The Meadows Operating Fund Contribution is ~\$26,000; approximately \$9k increase from 2023
- Approximately 50% of our annual budget

Park Budget

- Budget for 2023 ~ \$37,000; YTD ~ \$39,168
 - Includes escrow for new tractors
 - Overage will come out of Capital Improvement/General Funds
- Budget for 2024 \$41,680

Park Improvements

- Small bridge over ditch to easily walk to fields
- Added hopscotch
- Updated "library nook"
